Notes:

- For storage of O/size-OOG containers, additional 100% of the storage services, and additional 50% of the general services are to apply.
- For IMDG containers, additional 20% of the rates are to apply for all services.
- For import full containers processed as pre-arrival and direct delivery, if gate-out occurs within two days, storage and terminal fees will be applied as additional 100%.
- In case of any cancellation or delay of Inspection, Full Inspection or Stripping request or reservation date, "Transportation within Terminal" fee will be charged for the containers that are transferred to CFS yard.
- For Xray, Inspection, Full Inspection and Transfer Services of the containers already plugged in the yard stack, additional Plug in & Out services will be invoiced.
- The above tariff prices are indicated without VAT. Due to the law of value-added tax; the amount of VAT will be added to services subject to value-added tax.
- Container sweeping fee is charged additionally for each unstuffed (stripped) container. For stripping of IMDG containers, which requires "Customs" approval, additional 25 USD is invoiced for removing labels.
- Invoices are issued in TL currency over the US Dollars Selling Rate of Türkiye İş Bankası on the invoicing date. Yılport reserves the right to unilaterally use the currency exchange rate.
- Import storage days will be calculated from the date that vessel operation started.
- COMPANY TITLE AND DECLARATION NUMBER are obliged to be stated as explanation during the payment.
