1. General Conditions

- 1.1. This tariff covers all commonly incurred activities within the container terminal. The services, not included in the tariff, are provided based on mutually agreed fee by parties. For urgent issues, the terminal operator may provide services without looking for mutual confirmation and determines this service fee according to market price. Should the operating environment change, for example as a result of evolving regulations, we reserve the right to introduce tariff items associated with such changes by mutual agreement.
- 1.2. VAT is excluded from all prices. The invoices and payments will be in EUR currency. San Cataldo Container Terminal S.p.A. will invoice the Customer for all services carried out under this document and payment shall be made by the Customer within 7 days of the invoice date. In case of overdue invoices, daily interest rate of Bank of Italy shall be imposed till the payment day. In case of any disputes, the undisputed part of the invoice shall immediately be paid.
- 1.3. Rates and prices established in this tariff are for services and operations carried out under normal conditions and during ordinary working hours.

1.4. Working Hours & Overtime Rules

Working Hours:

1st Shift: 07:00-13:00 2nd Shift: 13:00-19:00 3rd Shift: 19:00-01:00 4th Shift: 01:00-07:00

Below table shows the overtime charges that will be applied additionally for the service rates specified in the items 2, 3, 5, 8, 9, 10, 11 and 12 in this document.

1.5. Waiting/Idle Time/Gang Cancellation

Waiting time from 1 to 60 minutes will be calculated as 1 hour. Waiting time in excess of 60 minutes will be assessed in 60-minute increments. This rate will be applied as 1000 EUR per hour per Gang.

- 1.6. For import containers, storage will start by the day that vessel operation started and for export containers storage will end by the last export container loaded to the vessel.
- 1.7. Units greater than 20' to 40' are calculated as 2 TEU (includes 22', 23', 24, 30, 40' units). 45' containers are calculated as 2.25 TEU.
